**CONCEPT NOTE**

The Directorate of Archaeology intends to produce Quickies and Short Documentaries on different Archaeological sites of the state with the motive to restore it and bring the existence of those sites into the light of the common people. The Department intends to make the general mass aware of the importance and value of the ancient monuments in different sites and the different ways that are helpful in preserving them in future. This project will include video of Madan Kamdev, Pingaleswar, Ganesh Temple at Abhyapuri, Rudreswar Devalaya, Aswaklanta Devalaya, Ambari, Sankhya Devi, Na-Nath, Rajbari, Deoparvat, Na-Pukhuri, Siva DouL, Pohu Garh, Fakuwa DouL, Charaideo Maidam, Mairamara Than, Borpukhuri, Podum Pukhuri, Ghuguha DouL, Maghnowa DouL, Garh DouL.

This RFP document is in connection with production of **Quickie** on the archaeological sites and **Short Documentary-Film** to create awareness for preservation of sites and monuments of Assam.
